	AVAILABLE CERTIFIED PEF This is a multi-criteria method for measuring environmental performance, promoted by the EU.	Marca Corona is amongst the first industries in the ceramic sector to have a PEF declaration that has been certified by an independent organisation. 	SOURCE OF RAW MATERIALS Transparency in the selection of raw materials.	Marca Corona uses only materials that have been identified in terms of origin, extraction site and methods for reduction of environmental impact. The availability of this information is certified by an external party.	<b>1</b>
